EXHIBITOR’S AGREEMENT & SHOW REGULATIONS

1. The word “producer” as used here shall mean West Coast Toy Soldier Trade & Collector’s Show (AKA “The West Coaster”).
2. Show is strictly limited to Toy Soldiers & Related items only!
3. Courtesy admission will be strictly limited to: **Exhibitors and one named helper for the first two tables, one helper per additional two tables thereafter.**
4. Set-up time will begin at 6:30 a.m. - **Exhibitors may not begin packing for move out until 3:00 p.m.**
5. Cost for exhibitor space is \$75.00 for each 6’ table. Subletting or sharing of tables by more than one dealer, collector is not permitted. Spaces purchased after December 1, 2016 are \$85 per each 6 foot table space.
6. Empty boxes, wrapping paper, etc. should be hidden from view. No displays, etc. are to be placed in or block aisles. Aisles and walkways must be kept clear at all times.
7. All dealings conducted by exhibitors must be performed as not to infringe upon the rights of other exhibitors or offend visitors to the show. No manner of attracting attention in a noisy or an undignified manner will be permitted. The producer retains the rights to restrict, exclude or evict exhibitors or exhibits which because of their method of operations, noise, or other features, become objectionable or which in the opinion of the producer may detract from the general character of the show, as this includes persons, things, printed matter or anything else the producer judges to be objectionable.
8. No signs, fliers, or printed matter shall be affixed to the walls or doors of the hotel and designated exhibit areas. Exhibitors or their agents shall not damage or deface walls or floors of the building.
9. The exhibitor is advised that the producer assumes no liability or responsibility to insure the safety or protect in any way the property of the exhibitor from fire, theft, malicious mischief, accident or other cause. The exhibitor is charged with the responsibility of protecting his own property at all times during the show and must have an attendant in charge of this table during show hours.
10. The exhibitor expressly releases the management and the promoters of the show from any and all liability for damages, injury, or loss arising out of or in conjunction with the use of the space or ground in the show or the display and/or sale of merchandise therein.
11. Each exhibitor is responsible for the collection and payment of the California State Taxes.
12. Exhibitors accept full responsibility for any injury or loss to themselves or their property, however such loss or injuries may be caused. Exhibitors expressly release the promoter, the promoter’s employees or contractors, and the Wyndham Anaheim Garden Grove Hotel from liability for loss or injury due to strikes, labor disputes, lock-outs, or acts of God. Exhibitors signify their acceptance of these conditions by applying for table space.
13. **ROOM RESERVATIONS MUST BE RECEIVED AT THE HOTEL BY December 15, 2016 FOR GUARANTEED ACCOMMODATIONS AT SHOW RATE.**
14. Only vendors who have purchased a table will be assigned to the vendor floors.
